



Taos Community Foundation Women Give Taos Grant Announcement – 2020

Taos Community Foundation is pleased to announce the Women Give Taos Impact Grant opportunity for 2020. Eligible Non Profit Organizations serving <u>Women and Girls</u> in Taos and Western Colfax Counties are invited to apply for funding to support <u>impactful</u> and transformative project, or enhancement of service proposals meeting one or more of the WGT priorities (see below).

One grant of \$30,000 will be awarded. Funds should be expended within 12 months of the date of the award.

Grants can be awarded to qualified 501(c) (3) nonprofit organizations, federally-recognized Indian tribes, public schools, and governmental agencies. Grants cannot be made to individuals.

<u>Instructions for completing and submitting the application</u>

<u>Applications must address one or more of the Women Give Taos Impact Grant Application 2020 priorities</u> listed below.

- Life Skills /Employment, parenting, preparation and training
- Access to Educational Opportunity
- Emotional and physical health (including addiction and teen pregnancy)
- Healthy development and personal authority of young girls
- Violence societal and domestic

The proposal should clearly identify the WGT priority (ies) addressed in the application. In your answers to the questions in the application, please provide specific information on the way in which this grant award of \$30,000.00 would allow your organization to <u>develop a new project</u> or <u>enhance your current activities</u> to directly address these priorities.

Deadline and Submission Instructions

Applications should <u>only</u> be submitted by email transmission, in PDF format. Submissions will not be accepted in hard-copy or fax, unless previously approved by TCF. Only one application may be submitted per organization during the open submission time period.

The deadline for submission is: January 31, 2020 by 4:00 PM.

Applicants will be notified of receipt of application materials by email. Incomplete or late submissions will not be considered.

Please do not include newsletters, photographs, or marketing material as supplements to your submission.

Deliberation/ Notification

Applications will be reviewed by the WGT Grants Committee for funding consideration and grant award recommendations to the Women Give Taos membership. Applicants selected for further consideration may receive a formal invitation to submit additional information, including a 2 minute video presentation describing their proposal.

Applying for and/or receiving this Grant does not preclude application to other TCF funding opportunities.

Please note, however, that organizations which have received the Women Give Taos Impact Grant award are ineligible to apply for the award in the following year.

Organizations that have outstanding Final Grant Reports to TCF <u>are not eligible</u> to submit any applications for funding until all previous grant reporting requirements have been met, and all previous awarded grants are considered "Closed – In Good Standing".
